

## 2010 Elgin Wine Festival

### Festival Exhibitor Agreement

(hereinafter "Vendor")

WHEREAS, the Elgin Wine Festival is a public event organized and coordinated by EWF;

WHEREAS, EWF and the Vendor wish to promote products and/or services to attendees at the Elgin Wine Festival, and agree that the products and/or services to be offered to the public at the Elgin Wine Festival should be of the highest quality possible;

NOW, THEREFORE, in consideration of the mutual promises contained herein, sufficiency of which is acknowledged, the parties agree as follows:

1. Vendor Location: The Elgin Wine Festival takes place at Festival Park in Elgin, Illinois on Saturday, May 29, 2010. EWF agrees to provide Vendor with space at the Elgin Wine Festival at which Vendor will display or sell products and/or services as listed in Paragraph 6. Vendor agrees that EWF shall have sole authority and discretion in the assignment of the spaces at the Elgin Wine Festival. Vendor agrees to the fees, payment schedule, hours of operation and all additional requirements as set out in the following paragraphs.
2. Amenities: EWF agrees to provide Vendor with the following amenities at Vendor's space location:
  - (a) One (1) 10'x10' tented display space
  - (b) One (1) 8' skirted table
  - (c) Two (2) chairs
  - (d) Ten (10) entry passes to the Festival
  - (e) Four (4) staff badges for Vendor booth
  - (f) One (1) booth sign with Vendor name
  - (g) Vendor listing in souvenir Program
3. Payment: The Vendor agrees to pay EWF a fee of **\$600.00** for the vendor space and amenities listed above. The Vendor agrees to pay 100% of this fee upon execution of this Agreement. **The signed Agreement and payment are due to EWF no later than April**

**16, 2010.** The Vendor's payment which accompanies this Agreement shall be refunded in full if this offer is not accepted by EWF.

4. Hours of Operation: (a) The Vendor agrees to continuously operate its booth during the official operating hours of the Event as:

Saturday, May 23, 2009      1:00PM to 7:00PM

(b) The Vendor shall be permitted to set-up its booth vendor space between 2:00PM and 5:00PM on Friday, May 28, 2010 or 8:00AM and 12:00PM on Saturday, May 29, 2010. No motor vehicle access will be permitted to and from the Vendor's space at any time during the operating hours of the Event.

(c) The Vendor shall not be permitted to strike Vendor's area until 7:00PM on Saturday, May 29, 2010 and shall have all its property removed from the Elgin Wine Festival site by 12:00AM Saturday, May 29, 2010. Failure to have all property removed by 12:00AM Saturday, May 29, 2010 may result in EWF removing the property at the Vendor's sole expense.

5. Vendor Obligation: The Vendor also agrees:

- (a) To clean and secure the Vendor's space at night;
- (b) To comply with arrangements made by EWF for removal of waste and recycling from site;
- (c) To comply with any other rules or regulations established by EWF for Vendors and the Elgin Wine Festival;
- (d) To provide a list of products/services to be displayed/sold (Note: the sales or sampling of any food product may require a temporary food service permit from the Kane County Health Department. Vendor is responsible for securing this permit prior to the Festival.):

6. Insurance: The Vendor agrees to provide to EWF on or before April 23, 2010, a current certificate of insurance which shall be effective for the dates of the Elgin Wine Festival, and which will provide for coverage, which shall include but not be limited to general liability coverage in the amount of at least \$2,000,000 (Two Million Dollars). Elgin Wine Festival, LLC, Comcast Corporation, the City of Elgin and Northern Illinois Special Recreation Association (NISRA) shall all be included on said certificate as additional insureds.

7. Liability: The Vendor agrees to pay for any damage done by it, its agents or employees to any personal or real property (e.g. tents, tables, structures, etc.) provided by or through EWF to the Vendor at the Elgin Wine Festival.

8. Breach: The Vendor agrees that all fees paid EWF are non-refundable, and that any failure on the Vendor's part to comply with this agreement shall be a breach of this Agreement. In the event of breach by the Vendor, EWF shall be entitled to terminate this Agreement and retain all fees paid by Vendor as liquidated damages for the Vendor's failure to comply with this Agreement. EWF may also demand Vendor immediately remove its property and vacate the space in which case the Vendor agrees to forfeit all payments to EWF as liquidated damages.
9. Indemnification: The Vendor agrees to indemnify EWF, any officer, employee of EWF, the City of Elgin and NISRA from any and all fees, costs and expenses incurred by them in connection with any claim, lawsuit, or proceedings arising out of or in connection with any act or omission of the Vendor or its agents in connection with the Vendor's involvement with the Elgin Wine Festival.
